The Milwaukee Better Buildings Challenge (MBBC) is a public/ private initiative that seeks to increase energy efficiency in the City of Milwaukee, and reduce energy usage by 20% in participating Milwaukee buildings by 2020. MBBC will utilize City of Milwaukee resources such as the Milwaukee Energy Efficiency program (Me²) to provide commercial buildings the support necessary to increase energy efficiency. MBBC participating organizations are asked to support this initiative by upgrading their buildings to be more energy efficient, and publically advocating for city-wide energy efficiency awareness.

- ✓ Explore Me² to receive rebates for energy efficiency projects completed by May 2013
