Who needs an Auto Wrecker License?

All persons, firms or corporations engaging in the business of buying, selling, exchanging or dealing in the business of an Auto Wrecker.

Definition

Auto wrecker means every person who buys motor vehicles for purposes of dismantling or disassembling, or who dismantles or disassembles any such motor vehicle for the purpose of dealing in the parts thereof.

License Period

License expires 2 years from date of issuance.

License must be issued within 1 year of approval, or a waiver from the Licenses Committee is needed.

Forms Needed

- Business License Application (ccl-busapp)
- Auto Wrecker License Supplemental Application (ccl-awapp)

Fee

\$250 for main yard

\$50 for each additional yard used for storing salvaged materials

Record of Purchases

Per Milwaukee Code Ordinance 93-23, every licensed Auto Wrecker shall keep a log of all vehicles purchased, or received, open to investigation by the Milwaukee Police Department.
