It is hereby agreed between the undersigned as owner, by himself, or his agent, and the City of Milwaukee, that for and in consideration of the permit to be issued by the Commissioner of City Development that the fire alarm equipment described in this application will be installed or altered in accordance with the regulations of Chapter 222 of the Milwaukee Building and Zoning Code and all amendments thereto and with all other laws and ordinances pertinent thereto. It is further agreed that an electrical licensee duly licensed under the regulations of Chapter 222 will install the electrical equipment as described in this application for permit in a safe, legal, and workmanlike manner as regulated in Chapter 222 aforesaid.

It is further agreed between the undersigned as owner, by himself, or his agent, and the City of Milwaukee, that for an in consideration of the permit for installation or alteration of electrical equipment as above described, to be issued and granted by the Commissioner of City Development, that the owner hereby grants a City of Milwaukee electrical inspector the right to enter the above designated premises during usual working hours in order to make all inspections that the Department of Neighborhood Services deems necessary to determine if all laws and regulations pertaining to the above designated electrical equipment have been complied with.

I further declare that an asbestos project as defined in Chapter 66 of the Milwaukee Code of Ordinances will not be included in the work performed under this permit.
