NEW DEVELOPMENTS

E. KILBOURN AVE. – N. JACKSON ST. TO N. JEFFERSON ST. (4TH) (POLICE DISTRICT 1)

It is anticipated that on Saturday, September 6, 2014 from 4:00PM (2:00PM set up) to 11:00PM that this roadway will be closed for the WMSE Backyard BBQ. (Germaine Speth – Work: 286-3915)

N. 60TH ST. – W. CENTER ST. TO W. APPLETON AVE.; N. 107TH ST. – STH 145 BRIDGE TO A POINT 900' NORTH; N. 54TH ST. – W. CAPITAL DR. TO W. FOND DU LAC AVE.; N. 68TH ST. – W. CAPITAL DR. TO W. HAMPTON AVE.; W. KEEFE AVE. – N. 20TH ST. TO W. HOPKINS ST.; S. MUSKEGO AVE. – W. BECHER ST. TO W. FOREST HOME AVE.; S. 2ND ST. – W. NATIONAL AVE. TO W. SCOTT ST. (2ND 5TH 6TH 8TH 10TH & 12TH) (VARIOUS POLICE DISTRICTS)

It is anticipated that the paving of these roadways will restrict traffic.

INDIAN SUMMER (4TH) (POLICE DISTRICT 1)

Indian Summer will be in progress from Friday, September 5, 2014, through Sunday, September 7, 2014. It is expected that N. Harbor Dr. between E. Michigan St. and E. Erie St. will be closed to traffic when the surrounding area gets congested. Motorists may use N. Milwaukee St. as an alternate route. (Germaine Speth – Work: 286-3915)

PROJECTS IN PROGRESS

E/W WELLS ST. BETWEEN N. PLANKINTON AVE. AND N. WATER ST. (4TH) (POLICE DISTRICT 1)

Bridge repair work has closed this roadway to traffic. Eastbound and westbound traffic is detoured to E/W Kilbourn Ave.

W. LISBON AVE. – N. 30TH ST. TO N. 31ST ST. (15TH) (POLICE DISTRICT 3)

It is anticipated that this bridge will be closed until the end of November, 2014.

N. SHERMAN BLVD. – W. CAPITOL DR. TO W. FIEBRANTZ AVE. (7TH) (POLICE DISTRICT 7)

Sewer work is restricting traffic to one lane for each direction in the east half of the roadway. (Mary Dziejwiontkoski - Work: 286-2460)

N. 35TH ST. – W. CAMERON AVE. TO W. VILLARD AVE. (1ST) (POLICE DISTRICT 7)

The reconstruction of this roadway will restrict traffic on this street. (Mary Dziejwiontkoski – Work: 286-2460)

W. HAMPTON AVE. – N. GREEN BAY AVE. TO N. TEUTONIA AVE. (1ST) (POLICE DISTRICTS 5 & 7)

It is anticipated that starting Monday, May 19, 2014 that the repaving of this road will begin and restrict traffic to one lane for each direction in the south half of the roadway for Stage I. Stage II will have one lane for each direction in the north half of the roadway. (Mary Dziejwiontkoski – Work: 286-2460)

S. WHITNALL AVE. – 115' N. OF E. HOLT AVE. TO E. HOLT AVE. (14TH) (POLICE DISTRICT 6)

Sewer work will be restricting traffic at this location. (Lynn Des Jardins – Work: 286-0447)

S. 76TH ST. – W. O'CONNOR ST. TO W. KEARNEY ST. (10TH) (POLICE DISTRICT 3)

It is anticipated that starting Saturday April 12, 2014 that this roadway will be closed due to the reconstruction of the bridge at this location. (State of Wisconsin DOT)

W. APPLETON AVE. – W. CAPITOL DR. TO N. 107TH ST (2ND, 5TH) (POLICE DISTRICTS 4 & 7)

The paving of this roadway will restrict eastbound and westbound traffic. (State of Wisconsin DOT)

S. HOWELL AVE. BRIDGE SOUTH OF E. OHIO AVE. (14TH) (POLICE DISTRICT 6)

Due to repairs on this bridge traffic will be restricted starting in September, 2014. (Craig Liberto – Work: 286-3294)

S. 35TH ST. BRIDGE BETWEEN W. FOREST HOME AVE. AND W. CLEVELAND AVE. (8TH, 11TH) (POLICE DISTRICTS 2 & 6)

Due to repairs on this bridge traffic will be restricted to one lane for each direction in the east half of the roadway starting in September, 2014. (Craig Liberto – Work: 286-3294)

S. 27TH ST. – W. HOWARD AVE. TO UNION PACIFIC RAILROAD/STH 241 (11TH, 13TH) (POLICE DISTRICT 6)

It is anticipated that starting Monday March 24, 2014 that the reconstruction of this road will restrict traffic to one lane for each direction in the east half of the roadway for Stage I. Stage II will have one lane for each direction in the west half of the roadway. (Mary Dziejwiontkoski – Work: 286-2460)

N. WATER ST. – E. WELLS ST. TO E. KILBOURN AVE; E. KILBOURN AVE. – N. WATER ST. TO N. MARKET ST. (4TH) (POLICE DISTRICT 1)

Work on City Hall is restricting traffic on these roadways.

N. BROADWAY ON-RAMP AT E. CLYBOURN ST; N. JACKSON ST. ON-RAMP AT E. CLYBOURN ST. (4TH) (POLICE DISTRICT 1)

Due to freeway work, the on-ramps at these locations are closed. (State of Wisconsin DOT)

N. MILWAUKEE ST. AT E. CLYBOURN ST. (4TH) (POLICE DISTRICT 1)

Due to freeway work, the off-ramp at this location has been converted to an on-ramp for eastbound to southbound freeway traffic. (State of Wisconsin DOT)

N. 95TH ST. – W. WISCONSIN AVE. TO A POINT SOUTH (10TH) (POLICE DISTRICT 3)

Wisconsin Department of Transportation Freeway work has closed this roadway to traffic.

EAST TOWN FARMERS MARKET – E. KILBOURN AVE. FROM N. JEFFERSON ST. TO N. JACKSON ST. (4TH) (POLICE DISTRICT 1)

This event will be closing westbound E. Kilbourn Ave. from N. Jefferson St. to N. Jackson St. from 6:00AM to 1:00PM every Saturday from June 7, 2014 through October 4, 2014 excluding July 12, 2014. (Germaine Speth – Work: 286-3915)

W. MITCHELL ST. – S. 4TH ST. TO S. 5TH ST. (12TH) (POLICE DISTRICT 2)

The re-decking of this bridge has closed this roadway to traffic. (State of Wisconsin DOT)

E. NORTH AVE. – N. FARWELL AVE. TO N. PROSPECT AVE. (3RD) (POLICE DISTRICT 1)

It is anticipated that on Friday, August 29, 2014 from noon to 11:00PM that this roadway will be closed for The Harley Fest North Ave Party. (Germaine Speth – Work: 286-3915)

E. JUNEAU AVE. – N. EDISON ST. TO N. WATER ST (4TH) (POLICE DISTRICT 1)

It is anticipated that on Saturday, August 30, 2014 from (8:00 a.m. setup) 2:00 p.m. to 11:00 p.m. that this roadway will be closed for a Harley Rally. (Germaine Speth – Work: 286-3915)

N. BROADWAY – E. ST. PAUL AVE. TO E. MENOMONEE AVE. (4TH) (POLICE DISTRICT 1)

It is anticipated that from 6 p.m. Friday, August 29, 2014 to Sunday, August 31, 2014 that this roadway will be closed for the Third Ward Art Festival. (Germaine Speth – Work: 286-3915)

LABOR DAY MARCH (4TH) (POLICE DISTRICT 1)

It is anticipated that on Monday, September 1, 2014 starting at 11:00 a.m. that the Labor Day March will be in progress and close the following streets. North on N. 4th St. to W. Wisconsin Ave. to N. Milwaukee St., south on N. Milwaukee St. to E. Chicago St. and east on E. Chicago St. to the main entrance at Summerfest. (Germaine Speth – Work: 286-3915)

JAZZ IN THE PARK AT CATHEDRAL SQUARE – E. KILBOURN AVE. FROM N. JEFFERSON ST. TO N. JACKSON ST. (4TH) (POLICE DISTRICT 1)
