**NO NEW DEVELOPEMENTS**

**PROJECTS IN PROGRESS**

**N. HOLTON ST. – E. HADLEY ST. TO E. CHAMBERS ST. (6<sup>TH</sup>) (POLICE DISTRICT 5)**

It is anticipated that starting Monday, December 1, 2014 that this roadway will be restricted to one lane for each direction on the proper side of the road due to sewer work. (Mary Dziejwiontkoski – Work: 286-2460)

**E. LOCUST ST. – N. CAMBRIDGE AVE. TO N. NEWHALL ST. (3<sup>RD</sup>) (POLICE DISTRICT 1)**

It is anticipated that starting Monday, December 1, 2014 sewer work will restrict traffic to one lane for each direction. (Mary Dziejwiontkoski – Work: 286-2460)

**N. HUMBOLDT BLVD. – E. CLARKE ST. TO 200' SOUTH OF E. CENTER ST. (3<sup>RD</sup>) (POLICE DISTRICT 5)**

It is anticipated that starting Monday, December 1, 2014 that sewer work will restrict traffic to one lane for each direction on the proper side of the road. (Mary Dziejwiontkoski – Work: 286-2460)

**W. LOCUST ST. – N. 24<sup>TH</sup> ST. TO N. 27<sup>TH</sup> ST. (15<sup>TH</sup>) (POLICE DISTRICT 3)**

It is anticipated that starting Thursday, November 20, 2014 that sewer work will close this roadway to eastbound traffic. Westbound traffic will be restricted to one traffic lane on the proper side of the road. (Mary Dziejwiontkoski – Work: 286-2460)

**N. 27<sup>TH</sup> ST. – W. CENTER ST. TO W. HADLEY ST. (15<sup>TH</sup>) (POLICE DISTRICT 3)**

It is anticipated that starting November 20, 2014 that sewer work will close this roadway to northbound traffic during working hours. One southbound traffic lane will be maintained. During non working hours one lane for each direction will be maintained.

**W. VLIET ST. – N. 54<sup>TH</sup> ST. TO N. HAWLEY RD. (10<sup>TH</sup>) (POLICE DISTRICT 3)**

It is anticipated that sewer work will restrict traffic on this roadway. (Mary Dziewiontkoski – work: 286-2460)

**S. 35<sup>TH</sup> ST. – POINT SOUTH OF W. BURNHAM ST. (12<sup>TH</sup>) (POLICE DISTRICT 2)**

Paving of this roadway is restricting traffic to one lane for each direction. (Mary Dziewiontkoski – work: 286-2460)

**W. BLUEMOUND AVE. – N. 95<sup>TH</sup> ST. TO N. 97<sup>TH</sup> ST. (10<sup>TH</sup>) (POLICE DISTRICT 3)**

Bridge work has closed this roadway to eastbound and westbound traffic. (State of Wisconsin DOT)

**W. LISBON AVE. – N. 30<sup>TH</sup> ST. TO N. 31<sup>ST</sup> ST. (15<sup>TH</sup>) (POLICE DISTRICT 3)**

It is anticipated that this bridge will be closed until the end of November, 2014.

**W. HAMPTON AVE. – N. GREEN BAY AVE. TO N. TEUTONIA AVE. (1<sup>ST</sup>) (POLICE DISTRICTS 5 & 7)**

It is anticipated that starting Monday, May 19, 2014 that the repaving of this road will begin and restrict traffic to one lane for each direction in the south half of the roadway for Stage I. Stage II will have one lane for each direction in the north half of the roadway. (Mary Dziewiontkoski – Work: 286-2460)

**S. WHITNALL AVE. – 115' N. OF E. HOLT AVE. TO E. HOLT AVE. (14<sup>TH</sup>) (POLICE DISTRICT 6)**

Sewer work will be restricting traffic at this location. (Lynn Des Jardins – Work: 286-0447)

**S. 76<sup>TH</sup> ST. – W. O'CONNOR ST. TO W. KEARNEY ST. (10<sup>TH</sup>) (POLICE DISTRICT 3)**

It is anticipated that starting Saturday April 12, 2014 that this roadway will be closed due to the reconstruction of the bridge at this location. (State of Wisconsin DOT)

**S. HOWELL AVE. BRIDGE SOUTH OF E. OHIO AVE. (14<sup>TH</sup>) (POLICE DISTRICT 6)**

Due to repairs on this bridge traffic will be restricted. (Craig Liberto – Work: 286-3294)

**S. 35<sup>TH</sup> ST. BRIDGE BETWEEN W. FOREST HOME AVE. AND W. CLEVELAND AVE. (8<sup>TH</sup>, 11<sup>TH</sup>) (POLICE DISTRICTS 2 & 6)**

Due to repairs on this bridge traffic will be restricted to one lane for each direction in the east half of the roadway. (Craig Liberto – Work: 286-3294)

**N. BROADWAY ON-RAMP AT E. CLYBOURN ST; N. JACKSON ST. ON-RAMP AT E. CLYBOURN ST. (4<sup>TH</sup>) (POLICE DISTRICT 1)**

Due to freeway work, the on-ramps at these locations are closed. (State of Wisconsin DOT)

**N. MILWAUKEE ST. AT E. CLYBOURN ST. (4<sup>TH</sup>) (POLICE DISTRICT 1)**

Due to freeway work, the off-ramp at this location has been converted to an on-ramp for eastbound to southbound freeway traffic. (State of Wisconsin DOT)

**N. 95<sup>TH</sup> ST. – W. WISCONSIN AVE. TO A POINT SOUTH (10<sup>TH</sup>) (POLICE DISTRICT 3)**

Wisconsin Department of Transportation Freeway work has closed this roadway to traffic.

**W. MITCHELL ST. – S. 4<sup>TH</sup> ST. TO S. 5<sup>TH</sup> ST. (12<sup>TH</sup>) (POLICE DISTRICT 2)**

The re-decking of this bridge has closed this roadway to traffic. (State of Wisconsin DOT)

**DOWNTOWN HOLIDAY PARADE (4<sup>TH</sup>) (POLICE DISTRICT 1)**

It is anticipated that on Saturday, November 22, 2014 from 9:00AM to 11:30AM this event will be in progress along the following route, closing these streets to traffic: N. Prospect Ave, E. Mason St. to E. Kilbourn Ave, E. & W. Kilbourn Ave. in the westbound roadway to N. Old World Third St; Old World Third St. from W. Kilbourn Ave. to W. Wisconsin Ave. Additional street closures for staging will be: N. Prospect Ave. from E. Kilbourn Ave. to E. State St.; E. Mason St. from N. Van Buren St. to N. Prospect Ave; E. Wells St. from N. Jackson St. to N. Prospect Ave; N. Cass St. & N. Marshall St. from E. Mason St. to E. Wells St. Streets closed for de-staging for this event will be: W. Kilbourn Ave. from N. 4<sup>th</sup> St. to N. 6<sup>th</sup> St; N. 4<sup>th</sup> St. from W. Kilbourn Ave. to W. Michigan St; N. 2<sup>nd</sup> St. from W. Wells St. to W. Michigan St; W. Wisconsin Ave. from N. Plankinton Ave. to N. 6<sup>th</sup> St. (Germaine Speth – Work: 286-3915)

**W. APPLETON AVE – W. CENTER ST. TO N. 59<sup>TH</sup> ST (10<sup>TH</sup>) (POLICE DISTRICT 3 & 7)**

It is anticipated that sewer work will restrict traffic on this roadway. (Mary Dziejwiontkoski – Work: 286-2460)

**S. 27<sup>TH</sup> ST. – W. HOWARD AVE. TO UNION PACIFIC RAILROAD/STH 241 (11<sup>TH</sup>, 13<sup>TH</sup>) (POLICE DISTRICT 6)**

It is anticipated that starting Monday March 24, 2014 that the reconstruction of this road will restrict traffic to one lane for each direction in the east half of the roadway for Stage I. Stage II will

have one lane for each direction in the west half of the roadway. (Mary Dziewiontkoski – Work: 286-2460)

**S. 1<sup>ST</sup> ST. BRIDGE SOUTH OF W. LINCOLN AVE. (14<sup>TH</sup>) (POLICE DISTRICTS 2 & 6)**

It is anticipated that starting Thursday, October 30, 2014 that this roadway will be closed to traffic due to construction of this bridge. This work is expected to be completed by November 26, 2014. (Mary Dziewiontkoski – Work: 286-2460)
