



# Building Analyst Training Grant for Workers

Full Grant valued at \$3,000 + \$300 Training Stipend to eligible

## WORKER ELIGIBILITY

- Employee of a Participating Me<sup>2</sup> contractors, employees of contractors seeking Me<sup>2</sup> Participation, or unattached workers
- Milwaukee County residents, 20½ years or older; with preference given to City residents.
- Income limitations – 300% of Federal Poverty Level – See table at right
- All males born on or after January 1, 1960 who registered for Selective Service between the ages of 18 and 26 (a waiver may be requested for those who did not register)
- U.S. citizens or resident aliens who are permitted to work in this country
- Must pass a reading and math test at the 8th grade level and effectively communicate to customers in writing
