SECTION 5: Payment Authorizations

At the homeowners discretion, Summit may either pay the contractor 100% of the loan upon completion of all agreed upon work, OR pay a 30% construction advance and the remaining 70% upon project completion. Home owner should select one of the following options:

Pay Contractor only upon completion of the work. Summit Credit Union will issue the Contractor a check in 1-2 weeks after the Contractor submits the Completion Certificate, including documentation of City permits.

Pay Contractor 30% down as a construction advance and remainder upon completion. After initial loan closing, Summit Credit Union will issue the Contractor a check for 30% of the loan amount in 1-2 weeks. Then upon completion of all work and obtaining all the required completion documents, Summit will send out a check to the contractor for the remaining balance in 1-2 works the Completion Certificate, including documentation of City permits.
