THEREFORE, IT IS THE INTENT TO AWARD UP TO FOUR (4) CONTRACTS TO THE FOUR (4) BIDDERS WHO ARE THE LOWEST RESPONSIBLE, RESPONSIVE AND MOST QUALIFIED BIDDER(S) COMPLYING WITH THE BID SPECIFICATION AND COMPLETION OF APPENDIX A., THE LIVING WAGE REQUIREMENTS-ATTACHMENT 2 AND THE 25% EMERGING BUSINESS ENTERPRISE PARTICIPATION REQUIREMENTS THAT IS DEEMED IN THE BEST INTERESTS OF THE CITY. AWARD WILL BE MADE IN TOTAL (GROUPS 1 THROUGH 7). LOW BIDDER(S) WILL BE DETERMINED FROM THE GRAND TOTAL OF ALL POSITIONS QUOTED IN EACH GROUP (GROUPS 1 - 7 OF APPENDIX A.). BIDDERS MUST QUOTE ALL POSITIONS LISTED IN EACH GROUP TO BE ELIGIBLE FOR AN AWARD.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
