THIS BID WILL BE AWARDED TO THE LOW RESPONSIVE AND RESPONSIBLE BIDDER COMPLYING WITH THE SPECIFICATIONS AND THE DELIVERY REQUIREMENTS.

FOR AWARD PURPOSES THE CITY WILL USE THE HOURLY RATE TIMES A FOUR (4) HOUR JOB PLUS THE PERCENTAGE OF DEALER MARKUP FOR OEM PARTS ON \$500 WORTH OF PARTS TIMES ANY ENVIRONMENTAL SURCHARGE AND SHOP SUPPLY CHARGE PERCENTAGES.

EXAMPLE FOR AWARD PURPOSES:

\$50/HOURLY RATE X 4 HOURS = \$200.00

\$500 OEM PARTS = \$500.00

DEALER MARK-UP ON PARTS: 10% = \$50.00

ENVIRONMENTAL SURCHARGE: 5% = \$37.50

SHOP SUPPLY SURCHARGE: 3% = \$23.63

TOTAL REPAIR JOB: \$811.13

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
