THIS WILL BE A MULTIPLE AWARD CONTRACT, AND THE AWARD WILL BE MADE AS FOLLOWS:

THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER COMPLYING WITH THE BID SPECIFICATIONS AND THE DELIVERY REQUIREMENTS WILL BE AWARDED 70% OF THE TOTAL ESTIMATED DOLLAR AMOUNT OF THE CONTRACT. THIS BIDDER WILL BE CONSIDERED THE PRIME VENDOR FOR THIS CONTRACT.

THE SECOND LOWEST RESPONSIVE AND RESPONSIBLE BIDDER COMPLYING WITH THE BID SPECIFICATIONS AND THE DELIVERY REQUIREMENTS WILL BE AWARDED 30% OF THE TOTAL ESTIMATED DOLLAR AMOUNT OF THE CONTRACT. THIS BIDDER WILL BE CONSIDERED THE BACK-UP VENDOR FOR THIS CONTRACT.
