BIDDERS MUST PROVIDE A UNIT PRICE PER CONTAINER FOR ON-SITE SHREDDING/DISPOSAL AND FOR SHREDDING/DISPOSAL AT VENDOR'S FACILITY OF CONFIDENTIAL PAPER MEDIA AND CONFIDENTIAL NON-PAPER MEDIA IN ORDER TO BE CONSIDERED FOR AWARD.

THE LOW TOTAL BIDDER SHALL BE DETERMINED FROM:

THE GRAND TOTAL OF MULTIPLYING THE QUOTED UNIT PRICES FOR THE CONTAINERS PROVIDED TO DSS FOR THE SHREDDING/DISPOSAL OF CONFIDENTIAL PAPER RECORDS AT THE VENDORS FACILITY TIMES THIRTY THREE (32) AND THE QUOTED UNIT PRICE FOR THE CONTAINERS PROVIDED TO DSS FOR THE SHREDDING/DISPOSAL OF CONFIDENTIAL NON-PAPER MEDIA AT VENDOR'S FACILITY TIMES ONE (1).

THE GRAND TOTAL OF MULTIPLYING THE QUOTED UNIT PRICES FOR THE CONTAINERS PROVIDED TO MPD FOR ON-SITE SHREDDING/DISPOSAL OF CONFIDENTIAL PAPER RECORDS TIMES FORTY NINE (49) AND THE QUOTED UNIT PRICE FOR THE CONTAINERS PROVIDED TO MPD FOR ON-SITE SHREDDING/DISPOSAL OF CONFIDENTIAL NON-PAPER MEDIA TIMES TWO (2).
