AN AWARD IN TOTAL OR MULTIPLE AWARDS MAY BE MADE FOR EACH INDIVIDUAL GROUP OR IN A COMBINATION OF GROUPS TO THE LOWEST RESPONSIBLE AND RESPONSIVE BIDDER COMPLYING WITH THE BID SPECIFICATIONS, COMPLETION/SUBMITTAL OF ATTACHMENT A - PRICING SHEET AND THE REQUIRED AFFIDAVITS FOR PROCUREMENT OF APPAREL-RELATED ITEMS, AND THE DELIVERY REQUIREMENTS.

GROUP 1 - SHOP TOWELS: LOW BIDDER WILL BE DETERMINED FROM THE GRAND TOTAL OF THE UNIT PRICES FOR EACH SUB-ITEM LISTED IN GROUP 1 (ITEMS 1A AND 1B). BIDDER MUST QUOTE BOTH SUB-ITEMS LISTED TO BE ELIGIBLE FOR AN AWARD OF GROUP 1.

GROUPS 2, 3, AND 4 - COVERALLS, SHOPCOATS, SHIRTS AND TROUSERS: BIDDER MUST QUOTE ALL SUB-ITEMS WITHIN A GROUP IN THE SAME FIBER CONTENT TO BE ELIGIBLE FOR AN AWARD OF THAT FIBER CONTENT. LOW BIDDER WILL BE DETERMINED FROM THE GRAND TOTAL OF THE UNIT PRICES QUOTED FOR THE SAME FIBER CONTENT IN EACH GROUP (GROUP 2 - ITEMS 2A THROUGH 2H; GROUP 3 - ITEMS 3A THROUGH 3F; GROUP 4 - ITEM 4A) BIDDER MUST QUOTE ALL SUB-ITEMS IN THE SAME FIBER CONTENT LISTED IN GROUP 2, GROUP 3, AND/OR GROUP 4 TO BE ELIGIBLE FOR AN AWARD OF A GROUP.

THE CITY RESERVES THE RIGHT TO REJECT A BID IF THERE IS A MINIMUM ORDER REQUIREMENT QUOTED.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN FIVE PERCENT (5%) AND THE DIFFERENCE DOES NOT EXCEED \$25,000.00.
