- a. When an officer is needed at the scene but the situation is **not life threatening**.
 - i. Loud Music
 - ii. Neighbor Trouble (non-violent)

C. District Notifications – Dial 935-7222 (2nd District)

- a. Non-emergencies when a squad is not needed
- b. FAX number 935-7112 (hot spot forms or drug complaint forms)
