## District Seven Contact Guide

- A. All Emergencies – Dial 911
  - a) All *life threatening* situations
  - b) All suspected crimes in progress (examples include, but not limited to)
    - i. Prowling
    - ii. Battery
    - iii. Robbery
    - iv. Shots Fired
    - v. Burglary
- B. Non Emergencies – Dial 933-4444
  - a) When an officer is needed at the scene but the situation is not life threatening, dial 9.
  - b) (Examples are, but not limited to)
    - i. Loud Music
    - ii. Neighbor trouble (non-violent)
- C. *To speak to a Communications Supervisor – Dial 935-7472*
- D. District Notifications – Dial 935-7272 or 935-7271 (7th District)
  - a) Non-emergencies when a squad is not needed. (Examples are, but not limited to)
    - i. Vacant house (on vacation and would like squad to check home)
  - b) FAX number 935-7115 (Hot spot forms or drug complaint forms)
- E. Drug and/or Nuisance House Reports
  - a) District Lieutenant - 935-7271
  - b) Community Liaison Officer - 935-7314
  - c) Community Prosecution Unit – 935-7278
- F. Information we need when you call. The what's happening, where's it happening, who's it happening to, or who's doing it.
  - a) What is happening
  - b) Where is it happening
  - c) Give the correct address if known or detail where the property is, the color, etc.
  - d) If the property is an apartment building, what is the apartment number?
  - e) Description of any suspects. (Be as descriptive as possible)
  - f) How can we contact you in the event more information is needed?
    - i. Tell us if you want to remain anonymous.
    - ii. Tell us if it is ok to contact you by phone or in person.
