COVID-19 vaccines available at mobile clinics citywide

Statement of Common Council President Cavalier Johnson May 21, 2021

I am encouraging residents citywide who have not yet been vaccinated against COVID-19 to do so.

To help these efforts, the Milwaukee Health Department is supporting numerous mobile vaccination clinics from May 22-28 (full schedule attached). These mobile vaccine sites will occur at a variety of times and locations to best meet residents where they are, and are a terrific option for those still needing a vaccine.

Receiving your vaccine now is even more important as the City's public health order and mask mandate will expire June 1, and I look forward to the discussion around the science behind this decision at next week's special Public Safety and Health Committee meeting.

We all still have a role to play in keeping our city safe and healthy long term, and getting residents vaccinated is a key part of that process. I've received my shots, and I urge others to do the same.
