Citizen Anti-Displacement Advisory Committee set for first public hearing

*Agenda includes communication about anti-displacement efforts in affected areas;
online comments to be accepted prior to hearing*

The Citizen Anti-Displacement Advisory Committee will be having its first virtual public listening session and hearing on **Friday, March 19 at 10 a.m.** The agenda includes communication relating to public comments that can be submitted to the Advisory Committee prior to the hearing.

As of February 2018, a report entitled the “*Anti-Displacement Plan for the Neighborhoods Surrounding Downtown Milwaukee*,” indicated that displacement of low-income residents may be occurring within certain neighborhood census tracts, especially those directly north and south of downtown. The Citizen Anti-Displacement Advisory Committee includes three Common Council members (**Alderwoman Milele A. Coggs, Alderman Russell W. Stamper, II and Alderman José G. Pérez**) and nine citizen members and was created to address the overall increasing poverty rates and low-income households moving out of the Milwaukee area because of increasing housing values.

The Advisory Committee will be examining a number of factors contributing to displacement, including rising rents and property taxes, and gentrification and its effects. The committee has pledged to hold a minimum of two committee meetings per year and will develop measures for preventing and limiting displacement and will make recommendations to the Common Council regarding potential anti-displacement legislative changes.
