### Who Needs an Ice Cream Peddler license?

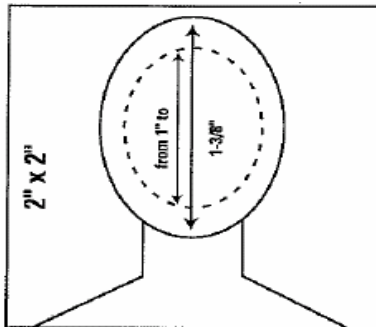
Every person selling and serving ice cream, popsicles and other frozen confections from a licensed Food Peddler vehicle, cart or carried container

### License Period

License expires one year from date of issuance

### Submit the following:

- \$75 License Fee
- Individual Application
- Ice Cream Peddler License Supplemental Application
  - One 2 x 2 inch clear colored full face photograph
    - The face size, measured from the bottom of the chin to the top of the head (including hair), should not be less than 1 inch or more than 1 3/8 inches. See sample below.



### Food Peddler License

The person/business that owns the Food Peddler vehicle, cart or carried container must also obtain a Food Peddler License.

### Fingerprinting

All individuals must report to the Police Administration Building for fingerprinting.

See the "Individual License Application Information" sheet for detailed instructions.

### Background Investigation

The Milwaukee Police Department (MPD) conducts background investigations of all applicants and files reports of its findings with the License Division.

If the police report finds any violations of the provisions of Milwaukee Code of Ordinances (MCO) 68-43.5.b. then the license shall be administratively denied. Any denials of a license may be appealed to the Licenses Committee of the Common Council.

### Exemptions

No permit shall be required if all sales are conducted at a temporary event per MCO Chapter 68.

### Age Requirement

Applicants must be at least 12 years of age and, if younger than 18 years of age, follow the provisions of MCO 68-45.
