## Ib cov lus tseem ceeb hais rau cov neeg xav muab ib cov lus rau pab Neeg Saib Xyuas txog cov Licenses rau lawv koj mus xav thaum lawv muab kev pom zoo:

1. Lub sij hawm teev saum toj yog teem caij tuaj mus hais txog daim ntawv tso npe rau daim license. Yog tias kev sib hais ntev tshaj lub sij hawm teem tseg, koj yuav tau tos me ntsis es koj mam hais.
2. Koj yuav tsum tuaj tim ntsej tim muag thiab hais raws nraim li qhov koj tus kheej tau raug los yog pom. (Koj yuav hais tsis tau rau tus neeg nyob npuab ntawm koj lub tsev, niam/txiv los yog lwm tus neeg; qhov no yog lwm tus hais ces pab committee yuav tsis txais.)
3. Pab committee yuav tsis txais cov ntaub ntawv (tsuas yog tus neeg sau tsab ntawv los yog cov neeg kos npe rau daim ntawv tuaj rau hauv lub rooj sib hais thiab txaus siab hais lus).
4. Cov neeg tsis pom zoo rau daim ntawv tso npe rau daim license yog cov xub hais lus; cov neeg txhawb nqa mam hais lus tom qab cov neeg tsis pom zoo hais tag lawm.
5. Thaum koj raug hu mus hais lus, koj yuav tau cog lus thiab nug kom qhia koj lub npe, thaib chaw nyob. (Yog tias koj lub npe/los yog lub xeeb txawv txawv thov muab sau.)

6. Koj yuav hais tau lus.
  - a. Tsuas yog hais cov lus txog daim ntawv tso npe rau daim license teev nyob saum toj.
  - b. Tsuas yog hais txog yam koj tus kheej tau ua tim khawv rau los yog tau pom.
  - c. Muab cov lus kom luv luv thiab hais txog seb lub lag luam tau muaj teeb meem los yog tej zaum yuav muaj teeb meem rau ib ncheeb tsam koj nyob.
  - d. Yog tias txog lub sij hawm koj los hais lus, cov lus koj xav hais twb muab hais tas rau pab committee lawm, koj yeej hais tau tias koj pom zoo raws li cov lus hais ua ntej lawm. Rov qab hais cov qub lus yuav pab tsis tau pab committee rau lawv txoj kev pom zoo.
7. Tom qab koj hais lus tag, cov neeg hauv pab Licenses Committee thiab tus neeg thov licensee yuav nug ib cov lus hais txog cov lus koj hais los yog lwm yam hais txog daim ntawv tso npe rau daim license.
8. Muaj kev sib tw nrog lub lag luam tsis yog yam ua rau kom tsis muab license rau los yog tsis kam tauj sij hawm rau daim license qub.
