- B. **Park East Development Code, Document Three; Pages 56 & 57; Block Development Standards/Block 19, are removed.**


In all other respects, except as herein modified by Amendment No. 5, the Redevelopment Plan for the Park East Redevelopment Project remains in full force and effect and in operation.


