ADDITIONAL NOTES:

1. Applications for all zoning changes and overlay approvals are available at <https://city.milwaukee.gov/ZoningApplications>.
2. Minor modifications to PD and deviations to overlays that were established after July 5, 2019: Follow expedited schedule dates and deadlines noted above.
3. Exhibit submittal deadline for CPC denotes submission of complete exhibits that have incorporated staff comments. We strongly recommend that you submit draft exhibits or meet with staff to review documents several weeks (depending on complexity of the project) in advance of the exhibit submittal deadline.
4. If need for an expedited schedule is demonstrated, it may be possible to expedite the ZND public hearing if approved by the Chair of ZND and the local alderperson at least 3.5 weeks prior to the ZND meeting, and required exhibits for the proposed zoning change are complete (all outstanding issues have been resolved) at the time of submittal.
5. Earlier CPC submittal deadlines may be requested in certain instances based on the scope and complexity of a particular project.
6. All deadlines are subject to change.
