3 Racism as a Public Health Crisis

The committee discussed the resolution and walked through the directive to create department questions. The committee agreed the following departments would receive the questionnaire: DOA (Contracting/Purchasing), DPW (Infrastructure/Operations) and the Health (Water Works) departments. Commissioner Ordonez suggested the use of Question Pro to collect departmental responses.

Data would provide a snapshot of health determinants for each department; what "indicators" would provide a specific response or score. Completed department questions for the following focus groups: organizational infrastructure, organizational workforce capacity and internal practices and processes.

- Commissioner Collins will compile all department questions on the directives table and circulate for review
