In accordance with Rule VIII, Section 6 of the Rules of the Fire and Police Commission, applicants who obtain a final passing score on any entry-level examination, and who meet certain criteria, *may* be entitled to additional points added to the final passing score.

**Military Veteran's preference points** are awarded to candidates who have military service defined within Section 230.16(7m)(a) Wis. Stats.

You may attach your claim form and required documents to your online application, return documents in person, have someone else return them for you, or return them by mail or email. The deadline for claiming preference points is **Friday, October 13, 2017**. This means that all required documents must be received at [fpcjobs@milwaukee.gov](mailto:fpcjobs@milwaukee.gov), in our office, *or* postmarked by **Friday, October 13, 2017**. **Submit only clear, legible copies of the verification document(s) as we do not return them to you.**

You must submit all required documentation as described on the reverse side of this form in order to receive preference points. Documents should be stapled behind the upper left hand corner of this form, or emailed to [fpcjobs@milwaukee.gov](mailto:fpcjobs@milwaukee.gov).

2017 Firefighter Application – **Military Veteran Preference Points Claim Form**

You must qualify under Wisconsin state statutes defining a veteran for this purpose.

Wisconsin State Statute 230.16(7m)(a) defines a “veteran” as a person who fulfills at least one of the following requirements:

1. Served on active duty in the U.S. armed forces for at least 180 days, not including training.
2. Was discharged from the U.S. armed forces because of a disability incurred during active duty or because of a disability that is later adjudicated by the U.S. department of veterans affairs to have been incurred during active duty.
3. Was honorably discharged from the U.S. armed forces.
4. Is eligible to receive federal veterans benefits.

I wish to claim military veteran preference points as follows:

**Documentation Required**

If you are an eligible veteran, you must attach an undeleted copy of your DD-214. Undeleted means that the copy you submit must include the bottom portion that indicates the type of discharge you received. Note: If you have not yet been released from active duty, you may present individual orders or a letter from your commanding officer attesting to honorable service and the dates thereof, in lieu of the DD-214.

**In all cases, the decision of the Fire and Police Commission is final as to the acceptability of documentation as proof of eligibility.** If you have questions, you may contact the City of Milwaukee Fire and Police Commission at 414-286-5000.
