THE FIRE AND POLICE COMMISSION TO HOLD THREE COMMUNITY MEETINGS FOR CONSIDERATION OF CHIEF OF POLICE CANDIDATE JEFFREY NORMAN

The City of Milwaukee Fire and Police Commission (FPC) is in the process of considering Acting Chief Jeffrey Norman for the position of Chief of Police of the Milwaukee Police Department. For the next step in this process, the FPC will host three community meetings in the month of October for City of Milwaukee residents to submit input and ask questions of Acting Chief Norman. These meetings will be held on the following dates and locations:

1. On Saturday, October 23, from 10:00 a.m. to 11:30 a.m., there will be an in-person meeting at the **Silver Spring Neighborhood Center**, 5460 North 64th Street, Milwaukee, WI;
2. On Thursday, October 28, from 6:00 p.m. to 7:30 p.m., there will be a **virtual meeting**; and
3. On Saturday, October 30, from 10:00 a.m. to 11:30 a.m., there will be an in-person meeting at **Anodyne Coffee Roasting Co.**, 224 West Bruce Street, Milwaukee, WI.

Residents will have an opportunity to submit comments or questions for Acting Chief Norman during the registration process or state them directly during the meetings.
