AWARD WILL BE MADE BY LINE ITEM TO THE LOWEST RESPONSIBLE AND RESPONSIVE BIDDERS BY MULTIPLYING THE HOURLY SERVICE CALL CHARGE AND SERVICE CALL RESPONSE TIME.

THIS CONTRACT WILL BE AWARDED TO BOTH A PRIMARY AND SECONDARY (BACKUP) BIDDER. THE LOW BIDDER WILL BE CONSIDERED THE PRIME VENDOR FOR THIS CONTRACT WILL BE AWARDED APPROXIMATELY 70% OF THE ESTIMATED AMOUNT OF THE CONTRACT. THE SECOND LOW BIDDER WILL BE CONSIDERED THE BACK-UP VENDOR AND WILL BE AWARDED APPROXIMATELY 30% OF THE ESTIMATED AMOUNT OF THE CONTRACT. THE AWARDED PERCENTAGES ARE ESTIMATES TOTAL ONLY AND SHOULD NOT BE CONSIDERED AS A GUARANTEE OF SERVICE WORK.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
