- BIDDER PROPOSED A CAB WIDTH IN EXCESS OF THE MAXIMUM CAB WIDTH PERMITTED BY THE FIRE DEPARTMENT.

AWARD WILL BE MADE TO THE LOWEST RESPONSIBLE AND RESPONSIVE BIDDER COMPLYING WITH THE SPECIFICATIONS AND THE SPECIFIED DELIVERY REQUIREMENTS WITH OR WITHOUT THE OPTIONAL TRAINING. THE CITY RESERVES THE RIGHT TO AWARD THE PUMPERS WITH OR WITHOUT THE OPTIONAL TRAINING FOR YEAR 2012, 2013, 2014, AND 2015, IF FUNDING IS AVAILABLE, WHICHEVER IS IN THE BEST INTERESTS OF THE CITY. VENDORS MUST BID ON THE PUMPERS AND THE OPTIONAL TRAINING IN ORDER TO BE CONSIDERED FOR AWARD.

NOTE: LOW BIDDER WILL BE DETERMINED FROM THE PRICE QUOTED FOR THE PUMPERS AND THE OPTIONAL TRAINING FOR YEAR 2012 AND WILL NOT INCLUDE THE PRICES QUOTED FOR THE POSSIBLE PURCHASE OF ADDITIONAL PUMPERS AND OPTIONAL TRAINING FOR YEARS 2013, 2014 AND 2015.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
