BIDDERS MUST QUOTE ALL ITEMS TO BE ELIGIBLE FOR AN AWARD.

FOR PRICE COMPARISON ONLY, LOW TOTAL WILL BE DETERMINED FROM THE **GRAND TOTAL** OF THE FOLLOWING:

- 1 THE AVERAGE TOTAL PRICE PER CUBIC YARD FOR LINE ITEMS #1 AND #2 MULTIPLIED BY THE ANNUAL ESTIMATED USAGE OF 1,500 CUBIC YARDS.
- 2 THE PRICE PER CUBIC YARD FOR LINE ITEM #3 (WINTER (HEAT) CHARGES - NOVEMBER AND APRIL) MULTIPLIED BY 1/4 THE ANNUAL ESTIMATED USAGE, OR 375 CUBIC YARDS.
- 3 THE PRICE PER CUBIC YARD FOR LINE ITEM #4 (WINTER (HEAT) CHARGES - DECEMBER THROUGH MARCH) MULTIPLIED BY 1/4 THE ANNUAL ESTIMATED USAGE, OR 375 CUBIC YARDS.
- 4 THE COST FOR EACH ADDITIONAL DELIVERY CHARGE QUOTED ON LINE ITEM #6 FOR ORDERS UNDER 5 CUBIC YARDS (CARTAGE) MULTIPLIED BY 4 DELIVERIES.
- 5 THE COST OF LINE ITEM #7 FOR DELIVERY WITHIN 2 HOURS MULTIPLIED BY 4 DELIVERIES.

THE CITY RESERVES THE RIGHT TO REJECT A BID IF THERE IS A MINIMUM ORDER REQUIREMENT QUOTED.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
