THE LOW BIDDER(S) SHALL BE DETERMINED BY MULTIPLYING THE QUOTED UNIT PRICE OF EACH TYPE OF FILTER DEVICE BY THE TOTAL COST OF REPLACEMENT FILTER(S) REQUIRED TO PROCESS A MINIMUM PASS-THROUGH VOLUME OF THREE HUNDRED SIXTY (360) GALLONS.

IF A LOCAL BUSINESS ENTERPRISE (LBE) IS A RESPONSIVE AND RESPONSIBLE BIDDER, THE LBE SHALL BE AWARDED THE CONTRACT PROVIDED ITS BID DOES NOT EXCEED THE LOWEST BID BY MORE THAN 5% AND THE DIFFERENCE DOES NOT EXCEED \$25,000.
