ORDER FOR JUDGMENT

Based on the authority of Wis. Stat. § 75.521(8), the motion of the City of Milwaukee (“City”), and on the pleadings and the record in this matter, the Court finds as follows:

1. The City duly filed a petition for judgment listing parcels of property affected by unpaid tax liens as shown on the delinquent tax rolls in the City of Milwaukee and Milwaukee County Treasurer’s Offices.

2. Milwaukee County has assigned its interest to the City of Milwaukee.

3. At least one year has elapsed since the properties became delinquent.

4. The City duly filed an affidavit of mailing indicating that the petition and legal description of the properties was mailed in compliance with Wis. Stat. § 75.521(3)(c).

5. The City duly filed an affidavit of publication and of default indicating that the notice of petition was published according to the requirements of Wis. Stat. § 75.521 (6), listing the 2 of

17 parcels which were redeemed by the statutory deadline of August 13, 2025, and listing the parcels which were dismissed.

6. The City's affidavit of publication and of default was supported by the affidavit of Joe Yovino, indicating publication of notice according to the statutory requirements.

7. Attorney Omar Mallick, appointed Guardian-ad-Litem by the City pursuant to Wis. Stat. § 75.521(12), fulfilled his/her duties under the statute as presented on the record.

NOW, THEREFORE, IT IS ORDERED AND ADJUDGED:

1. That there has been failure to redeem or answer by any person having the right to redeem or answer as provided by Wis. Stat. § 75.521, as to the following parcels: 47, 54, 71, 102, 113, 151, 177, 183, 199, 219, and 250

2. That all persons claiming under and through the person or persons having the right to redeem or answer by August 13, 2025 and by December 5, 2025 are foreclosed of all their right, title and interest and equity of redemption in and to the following parcels: 47, 54, 71, 102, 113, 151, 177, 183, 199, 219, and 250.

3. That the City of Milwaukee is vested with an estate in fee simple absolute in the below list of parcels subject to all unpaid taxes and charges which are subsequent to the latest dated valid tax lien appearing on the 2025 List of Tax Liens No. 2, filed herein and subject to recorded restrictions as provided by Sec. 75.14(4), Stats., and that all persons, both natural and artificial, including the State of Wisconsin, infants, incompetents, absentees and nonresidents who may have any right, title, interest, claim, lien or equity of redemption are forever barred and foreclosed of such right, title, interest claim, lien or equity of redemption:
