3) 66-22-8-b, 5-Day Hazard Control. All surfaces in violation of sub. 1 which have had a preventive cleaning as provided in par. a and which are accessible to children, must be taped or covered until additional procedures to control the lead hazards have been concluded.

4) 66-22-8-f, Final Cleaning. HEPA vacuum, wash with a general-purpose detergent and rinse with clear water of all interior surfaces in the dwelling or premises unit or supplemental location after the entire lead hazard reduction process has been completed.

FAILURE TO COMPLY

Failure to correct the violations noted herein within the time set, or failure to comply with the order as modified by the Commissioner of Health, and maintain compliance, may subject you to citations under Section 66-29 of the Milwaukee Code of Ordinances ("MCO") and daily forfeitures of \$100.00 to \$5,000.00 in the manner provided in Section 61-16. The minimum forfeiture shall be not less than \$500 for a second or subsequent conviction of a violation of MCO Section 66-29 committed within a 2-year period. Accumulated forfeitures recoverable in any one action shall not exceed \$30,000.

RIGHT TO APPEAL

You may file a written appeal to the Commissioner for review of the reasonableness of this order within the time specified for compliance. Contact the Commissioner's Office at 414 286-2165 in order to file an appeal.

RETALIATION

In accordance with MCO Section 66-22-3, no lessor shall take retaliatory action toward any lessee because of protected actions taken in response to suspected or known lead hazards. It shall be presumed that any attempt to terminate the tenancy, increase rent or other charges, reduce services, refuse to renew a rental agreement, or to otherwise harass or retaliate against a non-owner occupant within 24 months of the protected activities is done in retaliation and is void. The lessor may overcome the presumption of retaliation by demonstrating "good cause" for lessor's action by showing reasons other than those related to or caused by the occupant's protected activities, including but not limited to normal rental increases due to tax increases or increases in maintenance costs. An occupant may be evicted if the occupant fails to pay rent other than a rent increase prohibited by this subsection, commits waste upon the premises, or commits a substantial violation of a written rental agreement. Retaliatory action may subject you to issuance of a citation.

REINSPECTION FEES

In accordance with MCO Sections 60-53 and 66-22-4-d, a fee may be charged for any reinspection necessary to determine compliance with this order, except no fee shall be charged for the final reinspection when compliance is recorded. The fee is \$150.00 for the first reinspection and \$300.00 for the second and all subsequent reinspections. Reinspection fees shall be a lien upon the real estate where the reinspections were made and shall be assessed and collected as a special tax. If you wish to contest the assessment of a reinspection fee, contact the inspector and, if necessary, the inspector's supervisor. If no agreement is reached, you may contact the Commissioner's office at 414-286-2165 to file an appeal.

RENT WITHHOLDING

Uncorrected violations on properties may allow tenants to deposit their rent in an escrow account in the Department of Neighborhood Services under Section 200-22. The Commissioner may withdraw monies from such escrow accounts to make repairs to protect the health, safety and welfare of tenants.
