FIELD OPERATIONS INSPECTION SPECIALIST

(DPW - Infrastructure Services Division)

THE PURPOSE: To supervise and manage the review, approval and inspection of the private use of public rights of way including construction, excavation, occupancy and specialty permits issued by the City of Milwaukee. This involves working directly with private contractors, public and private utilities and private businesses to ensure compliance with plans, specifications and permit requirements.

ESSENTIAL FUNCTIONS:

- Direct and supervise inspection staff in the field review and inspection of all permitted use of the public rights of way to ensure compliance with plans, standards and reporting requirements.
- Review and update specifications, ordinances, inspection methods and procedures, inspection fees and summary reports.
- Communicate with contractors and various companies regarding their work in the public right of ways including investigation of non-permitted uses, violations of permit requirements, issuance of compliance orders and interpretation of city specifications and policies.
- Review and approve permit applications involving private utility and construction companies for excavation and/or occupancy within the public right of way. Determine special requirements including fees, deposits, restrictions and site restoration.
- Develop, coordinate and prepare contract documents including field review, inspection, contract management and payments for various DPW contracts involving street maintenance and sidewalk repair projects.
- Direct and supervise office personnel performing clerical support functions for the Field Operations section.
- Perform other job-related responsibilities as assigned

MINIMUM REQUIREMENTS:

Five (5) years of experience in an engineering/technical field such as field construction or maintenance, construction inspection, highway work, or other closely related field performing duties related to this position with a minimum of two (2) years of experience with the City of Milwaukee at the level of Public Works Inspector II (PR 540) or above.
